Additional Weatherization Incentive

Available for members participating in both the Commercial & Municipal Heat Pump Heating **and** Commercial & Municipal Weatherization Programs during the 2019 program year. Approved Weatherization Measures, air sealing and insulation, will receive an additional 15% incentive (Normally 35%).

Requires pre-approval by NHEC. Weatherization measures may be installed prior to or after the heat pump heating installation. Contact program administrator for additional details.

* Tonnage calculated by dividing rated Cooling Btu's by 12,000 (for example: 40,000 Btu's cooling / 12,000 = 3.33 tons. 3.33 tons x \$/ton = incentive)

** Wi-Fi connections must be enabled. Incentive not to exceed purchase price. Limit one Wi-Fi thermostat incentive per heat pump zone installed.

Qualifying equipment must be installed between January 1, 2019 and December 31, 2019 to be eligible for an incentive.

Member / Contractor may be required to provide documentation that equipment meets program guidelines.

Members should verify with contractor that electrical service and service entrance will meet loads of new equipment.

TERMS AND CONDITIONS

Application Offer: This program covers products purchased and installed on or after January 1, 2019. Details of this program, including incentive levels, are subject to change or cancellation without notice. Applications with required documentation must be postmarked within 30 days of installation. Funding is limited and will be available on a first come, first serve basis for complete applications until December 31, 2019 or until all funds have been expended, whichever occurs first.

Eligibility: Incentives are available to all New Hampshire Electric Cooperative (NHEC) commercial and municipal members purchasing new heat pump heating or water heating equipment for a new or existing building. The program encourages installation be completed by a licensed contractor. All products must meet the eligible equipment requirements. Participants who receive equipment incentives through another energy efficiency program offered by NHEC are not eligible to receive incentives through this program for the same equipment. Approval, Verification, and Inspection: This program is being administered by NHEC (Incentive Provider). The Incentive Provider reserves the right to verify sales transactions and to have reasonable access to your business to inspect the system installed under this Program. The member/contractor shall verify that the installed energy-saving measures meet all applicable building codes; zoning laws, local, state, and federal requirements; and other relevant requirements. The member/contractor is responsible for any applicable permits as required by aforementioned code/law. Applicants agree to retain all records associated with this application for at least 3 years after the purchase date.

Proof of Purchase: An invoice itemizing the purchased equipment and a copy of a recent electric utility bill must accompany each incentive application. The contractor's invoice copy must indicate the address where the equipment was installed, equipment type, make and model numbers and date of installation.

Application: This application must be filled out completely. The NHEC Member must sign the application. Submitted applications must be accompanied by the invoice and a copy of a recent electric utility bill.

Payment: Please allow up to 60 days for payment. Payment processing may take longer if information is missing on the application or if the equipment invoice or electric utility bill is not included.

Endorsement: The Incentive Provider does not endorse any particular manufacturer, contractor, vendor, product, retailer, system design or claim in promoting this program.

Limitation of Liability: The Incentive Provider is limited to paying the incentive specified; Incentive Providers are not liable for any consequential or incidental damages, or for any damages in tort connected with or resulting from participation in this program.
