

TERMS AND CONDITIONS

HEAT PUMP WATER HEATER EQUIPMENT REQUIREMENTS

Only ENERGY STAR® Certified Heat Pump Water Heaters meeting the minimum efficiency rating outlined in the incentives table are eligible for a rebate.

GENERAL REQUIREMENTS

Application Offer: This program covers products purchased and installed on or after January 1, 2022. Details of this program, including incentive levels, are subject to change or cancellation without notice. Applications for this program are provided by the NHSaves Energy Efficiency Programs. **Funding is limited and will be available on a first come, first serve basis** for complete applications until December 31, 2022 or until all funds have been expended, whichever occurs first. All equipment must be ENERGY STAR approved to be eligible for the rebate.

Application form: This application must be filled out completely, truthfully, and accurately. The customer must data, sign and submit the completed application along with all required documentation (copy of invoice) for specific rebates and/or incentives. By submitting the rebate application, the customer agrees to abide by these Terms and Conditions.

Payments: From the time the application is processed and approved, please allow 6-8 weeks for payment. Payment processing will take longer if information or documentation is missing from the application.

Proof of Purchase: The invoice itemizing the purchased equipment must accompany each rebate application form. The invoice must indicate the Equipment Make, Model Number, Size in gallons, Installation Date and Address, Total Install Cost and Proof of Payment.

Geographic Requirements: Offers valid only for residential electric customer in NH where the heat pump water heater rebate is offered by Eversource, Liberty, New Hampshire Electric Cooperative and Unitil.

Approval and Verification: This program is being administered by your Electric Utility and Energy Federation Incorporated jointly known as the "Rebate Providers". The Rebate Providers reserve the right to verify sales transactions and to have reasonable access to your residence to inspect the system installed under this Program. Customer's contractor will verify that the installed energy-saving measures meet all applicable building codes; zoning laws, local, state, and federal requirements; and other relevant requirements. Contractor is responsible for any applicable permits as required by code/law. Applicants agree to retain all records associated with this application for at least 3 years after the purchase.

Endorsement: Rebate Providers do not endorse any manufacturer, product, system design, or technology in promoting these offers.

Limitation of Liability: Rebate Providers are limited to paying the rebate and incentive specified. Sponsors and the Rebate Providers are not liable for any consequential or incidental damages or for any damages in tort connected with or resulting from participation in these offers.

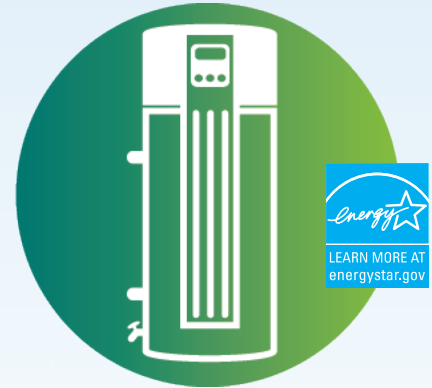

Eligibility: Incentives are available to all participating New Hampshire Electric Utility residential customers purchasing new water heating equipment for a new or existing residence. Businesses, non-profit and governmental organizations are not eligible. The program recommends installation to be completed by a licensed contractor. All products must meet the eligible equipment requirements. Participants who receive equipment incentives through another energy efficiency program offered by your Electric Utility are not eligible to receive incentives through this program for the same equipment. Rebate only valid on new units, cannot be used or refurbished.
