2025 NOMINATING COMMITTEE REPORT

The NHEC Nominating Committee is pleased to present its slate of candidates for the 2025 Board of Directors election. The committee, composed of seven board-appointed Co-op members, functions independently from NHEC's Board of Directors and Management team.

The role of the committee is to evaluate applicants and to nominate the candidates that will best contribute to the governance of the Co-op. When determining its nominations, the committee is guided by the Co-Op bylaws, directing it to use "its collective best judgment" along with "any other criteria which the committee in its discretion may consider." The committee weighed each of the applicants experience and expertise, along with the current and future needs and best interests of the Co-op and its members.

For the 2025 election, four three-year seats and one oneyear seat are open on the 11-member board. Directors may serve up to five consecutive three-year terms.

After reviewing nine applications, conducting interviews and thoughtful deliberations, the committee unanimously voted to nominate the following slate:

Three-Year Term (four seats)
